i. **RAP SURVEY RESULTS:** Re Upper Runyon Canyon Parking lot survey update located at 7317 Mulholland Drive, at the north entrance of Runyon Canyon Park.

Survey Results: LA Rec & Parks/CD4 survey is now closed. It addressed the future use of the upper lot at Runyon Canyon Park off of Mulholland Dr. It also addressed the Department of Recreation and Parks (RAP) has a proposal to install pay and display parking to help mitigate traffic safety issues, encourage greater parking turn over, and provide a source of revenue for a park monitor at the parking lot and to support possible capital improvement projects.

The RAP Survey options included these options:

- 1. Parking lot to open as was prior to closure.
- 2. Parking lot to open with paid parking stations with free parking hours.
- 3. Repurposing current lot to accommodate ride share pick up and drop off only.
- 4. Parking lot to remain closed.
