5. President's Report (Anastasia Mann)

- a. CD 4 Candidate Debate with Central Area NCs to be held on Sunday, February 16; 4-6 pm at John Marshall High School. Discussion of NC sponsors, format, candidate's participation.
 - Susan Collins (candidate) announced she is now a certified *write-in* candidate due approximately 300 of her signatures being deemed out of district.

Motion & Vote

Anastasia Mann made the Motion to approve up to a maximum of \$1000 for planning and Outreach expenses for the implementation of The CD4 Candidate Forum to be held in conjunction with six other Hollywood-Los Feliz-Wilshire NCs; Orrin Feldman 2nd to support up to \$1000; Board Vote: 18 yes; 0 No

- b. Area 9 Chair Board Seat Opening; Farewell & Thanks to Stefan Siegel who was serving as Area 9 Chair until his resignation. Seat opening has been posted on website. Replacement election date: February 19th meeting.
- c. **Public Records Act Discussion** reminder to board members of requirements of CPRA. Update on current request and efforts to comply.
- d. Confirm next meeting date: February 19, 2020.
- 6. First Vice-President's Report (Orrin Feldman)

- a. 6667 West Hollywood Boulevard is the site of Musso & Frank's restaurant. The restaurant's owners had applied to have their right to sell alcoholic beverages for onsite consumption extended to additional adjacent space into which the restaurant has expanded. The committee voted (7 to 0) to recommend that HHWNC support the application and support restaurant's additional request that the Planning Department waive the public hearing requirement. The Planning Department approved the application and waived the public hearing requirement within a few days following the committee's meeting on December 2, 2019. This may have mooted the need for HHWNC to take any action(s). The Planning Department's case no. is ZA-2019-6617-PAB-PAD. The CA CEQA no. is ENV-2019-6618-CE.
- b. 1724 -1744 N. Highland Avenue is the site of a mixed use retail/residential building which now is called Urban Redwood, but which had been known as The Jefferson. RWBP Highland, L.P., the building's owner applied to the City's Planning Department for a master conditional use permit for three new restaurants with indoor seating and outdoor dining along Highland Avenue and Yucca Street. The proposed hours of operation would be from 6 a.m. to 2 a.m. daily. The Planning Department's case no. is ZA-2019-5821-MCUP. The application was silent as to whether any additional discretionary entitlement request, scubas karaoke, live music, and/or dancing, were being requested. Following a presentation from the owner's representative, Christine Rivera of The Elizabeth Petersen Group, and a discussion, the committee voted (7 to 0) to recommend that the Board adopt the motion (below).

The committee voted to make the recommended motion at its 12/2/19 meeting. At the committee's meeting on 1/8/20, the committee met again with Ms. Rivera as well as Urban Redwood's Scott McCarter and Matthew Nichols, who is Urban Redwood's outside counsel.

Proposed Motion: HHWNC should not support, and should oppose, the application as presented.

Christine Rivera Update: Entitlement request change to two full line of alcohol restaurants vs. three. No change in hours.

c. **7865 W. Sunset Boulevard** - is the site of a Mobil gas station and convenience store. Sunset Fairfax Oil, LLC, the gas station's owner has filed an application with the City's Planning Department to ask for approval of a conditional use permit to authorize the sale of beer and wine for off-site consumption at the convenience store up until 11 p.m. daily. The Planning Department's case no. is ZA-2019-6201-CUB. Following a brief discussion, the committee voted (7 to 0) to recommend that the Board adopt the following motion:

Proposed Motion: HHWNC should not support, and should oppose, the application.

Orrin Feldman made the motion, Oren Katz 2nd. The motion passed (approve 17; oppose 1).

d. **7917 West Sunset Boulevard** - is the site of a new Veggie Grill restaurant to replace the Counter Burger restaurant, which closed last summer. The Veggie Grill has applied for a conditional use permit to sell beer and wine for on-site consumption (Type 41) at its new location, which will open following a remodeling of the restaurant's space. The proposed hours of operation at the new site

would be the same as the restaurant's previous site (the courtyard at 8000 W. Sunset Blvd.), which would be from 11 a.m. to 10:30 p.m. on Sundays through Fridays and from 11 a.m. to 11 p.m. on Saturdays. The Planning Department's case no. is ZA-2019-6657. Following a brief prevention from Elizabeth Valerio, the restaurant's architect and representative, the committee voted (6 to 0) to recommend that the Board adopt the following motion:

Proposed Motion: HHWNC should support The Veggie Grill's pending application for a new conditional use permit (Type 41) at its new location.

Orrin Feldman made the motion, Oren Katz 2nd. The motion was approved 18-0.
