PROCESS FOR RECONSIDERATION: Each Committee may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular meeting. The Committee, on either of these two days, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and Take an Action. If the motion to reconsider an action is to be scheduled at the next meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) A Motion for Reconsideration on the described matter and (2) a Proposed Action should the motion to reconsider be approved. - 2. Hollywood Community Plan Update -

The City's Planning Department released its latest proposed Hollywood Community Plan Update (HCPU) on August 7, 2020, along with a new proposed Hollywood Community Plan Implementation Overlay (CPIO), which the department expects would be adopted along with the new community plan.

The CPIO is a zoning tool which is designed to increase the production of affordable housing near transit corridors, improve urban design by establishing new standards, especially as it relates to what pedestrians experience, and safeguard historic resources. The CPIO also would replace the existing Transit Oriented Corridor rules, which provide incentives and bonuses to developers who provide affordable housing, in Hollywood.

The City's Planning Department's Linda Lou and Priya Mehendale will be making a presentation and taking questions from 6 to 7 p.m.

4. California Proposition 21 - is a rent control proposal, which will be on this November, 2020's ballot.

California Proposition 21 is a local rent control initiative. The ballot measure would replace the Costa-Hawkins Rental Housing Act (Costa-Hawkins), which was passed in 1995. The ballot measure would allow local governments to adopt rent control on housing units, except on (a) housing that was first occupied within the last 15 years and (b) units owned by natural persons who own no more than two housing units.

Under Costa-Hawkins, landlords are allowed to increase rent prices to market rates when a tenant moves out (a policy known as vacancy decontrol). The ballot measure would require local governments that adopt rent control to allow landlords to increase rental rates by 15 percent during the first three years following a vacancy.
