5. Public Official Reports

a) CD4 – Rachel Fox & Tabatha Yelos, Office of Councilwoman Nithya Raman Tabatha provided an update on Councilwoman Raman's motions that she made yesterday regarding housing feasibility, homeless and sustainability. As the weather gets warmer, multiple cooling centers have opened at open at several Los Angeles libraries.

Rachel is hosting a community meet up next week on Tuesday at 6pm. Anticipating the 4th of July holiday additional LA DOT parking enforcement officers will be around Runyon Canyon and Lake Hollywood. In addition she thanked the outgoing board members for their service.

b) LAPD – Hollywood & North Hollywood Divisions
Officer Brian White expressed his gratitude to the outgoing board members. He spoke about the
California re-opening and party house enforcement. Since Covid health orders have been removed
the enforcement of stopping water/power at party houses is no longer an option. Parties are
allowed now, its now a matter of if they are nuisance. LAPD aware of the tour bus issues currently
happening.

- c) LAFD Chief Hogan thanked the outgoing board members for their service. He spoke about the area around Runyon that was a concern as it was a buffer zone. Chief Hogan also spoke about additional hydrants near Wattles mansion and park. Regarding the 4th of July five large show permits have been permitted he will put together a newsletter that contains that information. The PEH pilot program (People Experiencing Homelessness) has been launched on the west side and he is looking to bring it to CD4. Chief Hogan spoke about the importance of having a fast response vehicle that is out in the community for 10 hour shifts as they try to get to fires quickly before the larger trucks can get there.
- d) 3rd Supervisorial District, Erin Seinfeld, Office of Supervisor Sheila Kuehl stated that only 55% of LA County residents 16+ years have been vaccinated. She noted Cal-OSHA will revote on masking in the workplace on 6/17. In additional she spoke about how the board passed a motion about establishing permanent guidelines for outdoor dining (make the temporary outdoor dining permanent).
- e) Los Angeles Department of Recreation and Parks, Stefanie Smith was in attendance.
- f) Hollywood Bowl/Stratiscope, Angela Babcock stated that with full capacity shows coming they will be having more DOT officers out to manage traffic. The Odin left hand turn lane was launched so ride shares and people parking in Lot B can use that moving forward. People can picnic prior to shows but the Hollywood Bowl isn't open off hours yet (for those wanting to exercise on the stairs).

6. President's Report (Anastasia Mann) continued / Transportation (Jeff Straebler)

a) Speed Hump DOT – Traffic Control Issue

Presenter: DOT

Lan Nguyen, Transportation Engineer, Traffic Surveys Section

ISSUE: Speeding, Street Racing Dangers. Speed Hump requests within HHWNC:

Lan Nguyen discussed the problems in the HHWNC areas and procedures of how to apply for speed humps. Lan answered questions from board members regarding specific locations.

Motion:

HHWNC requests DOT to consider and possibly escalate the following six requests for speed humps and/or other permanent means to mitigate illegal speeding, auto racing and other dangerous activities within our boundaries.

- 1) Area 9 Mulholland Drive between Multiview & Wrightwood. Drag racing
- 2) Area 5 Mulholland Drive in the Outpost Drive area (Brian knows) Drag racing between Outpost Drive intersection and west of 7230 Mulholland by City Lights.
- 3) Area 4 Orange Drive Between Hollywood Blvd & Franklin Ave 1745 1746 Orange Drive & possibly one north of that closer to Franklin @1775 Orange Drive. Drag racing, etc.
- 4) Area 4 6800 Camrose West of Highland (cars speed as soon as turning west off of Highland)
- 5) Area 6 Lower Nichols Canyon Road between 1849- 1953 Nichols Canyon Road (this site was already approved in the last budget and delayed- DOT has completed a study & approved). Racing, speeding.
- 6) Area 8 My Olympus & Oceana Drive 4 lane "sloped" speedway. Slope will likely eliminate speed humps but alternatively, possibly a roundabout or median to slow the cars? Speeding.

President Anastasia Mann made the motion, 2nd by Transportation Chair Jeff Straebler. The motion passed 15-0.

10. Committee Reports

a) Public Safety (Paul Jenkins)

i. Currently, our pedestrian signals (push-button crosswalks) are operating on timers. This was begun at the beginning of the Pandemic out of a concern that touch was a primary mode of transmission. Touch is no longer considered a primary way of spreading the virus. As discussed by the Dept. of Transportation in previous meetings, Los Angeles has one of the best algorithm-controlled traffic light systems in the world. This helps to speed up traffic, and most important, lower our carbon emissions.

Motion: HHWNC requests that the Department of Transportation restores the pedestrian pushbuttons back to their intended use. The request will go directly to Seleta Reynolds, GM, LADOT, with a copy to the Mayor's Office and the Council Office.

President Anastasia Mann made the motion on behalf of Public Safety Chair Paul Jenkins, 2nd by Transportation Chair Jeff Straebler. The motion passed 14-0.

b) Parks & Open Space (Jeffery Masino)

 Presentation by LA Rec. & Parks - Runyon Canyon Paid Parking Proposal - Upper Mulholland Parking lot, followed by discussion with public input. (Guest: LA Rec. & Parks representative) Possible Motion, Discussion, and Vote

Rec & Park representatives: Sean Hinton, Stefanie Smith & Tracy James

Stefanie Smith presented and spoke about:

- Runyon Canyon will close early on July 2, 3 and 4th in anticipation of the 4th of July holiday weekend,
- Runyon Canyon averages 3,500-5,500+ visitors a day
- Looking to add paid parking to the upper Mulholland parking lot
- Parking would be \$6/hr with revenue going to Rec & Parks
- Park Staff attendants to monitor and control the parking lot during peak hours

Public Comment: Jacquelin Sonderling, Mary Robinson, & Joe Kahraman

Motion: HHWNC request to keep the Mulholland parking lot closed until Rec & parks is able to hear from more members of the pubic at an open transparent meeting on this subject only hosted by HHWNC.

President Anastasia Mann made the motion, Business Chair Oren Katz 2nd. The motion passed 14-1.
