DRAFT Minutes

- 1. Call to order by President, Anastasia Mann at 6:04 pm.
- 2. Roll Call by Secretary, Darnell Tyler. Quorum established.

Absent: Transportation Chair Kyrstin Munson

- 3. **Approval of September 22, 2021 Minutes.** President Anastasia Mann made the motion to approve the minutes with corrections, 2nd by Area 8 Chair Serra Aladag. The minutes were approved unanimously.
- 4. Public Official Reports
 - a) LAPD SPECIAL REPORT, Captain Brent McGuyre, LAPD Hollywood Division regarding LAPD vaccination / COVID issues.

Captain McGuyre stated that Oct 19, 2021 all employees required to provide vaccination status. Approximately 75% vaccinated. City of Los Angeles has mandated all city workers be vaccinated by December 8, 2021. Discussed process for officers not following Covid guidelines.

b) CD4-Mehmet Berker, Office of Councilwoman Nithya Raman Mehmet stated that redistricting is still at the commission and is adoption of the new council district map should happen October 21 and final adoption by city council will happen October 28, 2021. Website to see proposal maps www.LACCRC2021.org. The rental assistance program is continuing for renters and landlords. Website is www.HousingIsKey.com. Mehmet, agreed to bring data to each HHWNC meeting about the success of their efforts regarding homelessness. Specifically, they would share the numbers of homeless encampments they have been successful in transitioning to housing from month to month so that stakeholders can hear about progress being made.

c) LAPD – Hollywood, Officer Brian White & North Hollywood, Officer Kurtis Delbar SLO Brian Oliver, Hollywood, Flats shared there has been a significant increase in robberies. He recommended to not walk on dark streets and walk in groups. There will be a coffee event supporting the Special Olympics at Aroma Café October 21.

SLO Brian White, Hollywood stated that LAPD participated in Community Walk October 13. The purpose of the walk was to add a community presence to Hollywood's entertainment district. They will be deploying additional resources for Halloween and will continue working on party houses.

SLO Curtis Delbar, NoHo LAPD shared that had been an increase in robberies of 56%, Increase in Robberies from a motor vehicle of 34%. Recommended to not leave items in your motor vehicle, lock your doors at home, make cameras visible and have lights on.

d) Neighborhood Prosecutor, Hollywood Division, Ethan Weaver Ethan shared that his office has filed charges against an underground nightclub and casino. His office has received complaints regarding 1510 Stanley Ave for noise complaints but can't go into detail regarding an ongoing investigation.

e) LAFD – Chief Armando Hogan

Chief Hogan stated approximately 72% of LAFD has received at least 1st shot and 68% have received the 2nd shot. All firefighters should be masked. LAFD is bolstering deployments and watching the weather as we move into the Santa Ana winds season. They are also putting in place contingency plans due to current Covid status. They are scouting locations for weather stations to monitor conditions. There is now a Heli-tanker and 4 water dropping located at Van Nuys airport in preparation for the season.

- f) 3rd Supervisorial District Rachel Sherrell, Office of Supervisor Sheila Kuehl
 Rachel mentioned that she's new to the east side communities. Supervisor Kuehl has pushed
 motions that make for an inclusive LA County, better support for the immigrant community. The
 County of Los Angeles has announced vaccine requirements for employees and has funds for small
 business legal aid.
- g) 46th Assembly District, Sophia Soudani, Office of Assemblymember Adrin Nazarian Sophia shared that Assemblymember Nazarian will be hosting a virtual self defense class. She offered their assistance with EED and stimulus checks if needed and stated that state rental assistance is still available.
- h) 50th Assembly District-Josh Kurpies, Office of Assemblyman Richard Bloom Melissa Kaufer from the Office of Assemblymember Bloom shared that the office has 10 Bills that have passed and been signed by Governor Newsom. The office is available to assist with EDD payments.
- i) Hollywood Bowl/Stratiscope, Angela Babcock Angela states that there are 9 shows left on the Hollywood Bowl schedule. The last show is scheduled November 3, 2021. There is a conflict November 2 and November 3 with Hollywood Blvd closures and traffic will be impacted.

j) John Frank, Los Angeles Public Library, Will & Aerial Durant Branch – update John provided an update stating the library has been open since June, full hours 6 days a week. Since reopening patronage has continued to increase.
