- 1. Call to order by President Anastasia Mann at 6:03 pm
- 2. Roll Call by Secretary, Darnell Tyler, Quorum established.

3. Approval of October 19, 2022, Minutes

President Anastasia Mann made a motion to approve the minutes as submitted, 2nd by 1st Vice President Stuart Ross. The minutes were approved 21-0.

- 4. President's Report by President Anastasia Mann
 - a) HHWNC ELECTION UPDATE: Lanee Basulto, Election Administrator, provided an update on status of upcoming NC Elections and HHWNC process for March 2023.

 Lanee.Basulto@lacity.org. The budget for the 2023 elections allowed for a hybrid election model. This will allow people to vote in person, or by mail allowing maximum participation for every neighborhood council. The website has been updated with candidate, voter resources and election materials. to make it easier and it's also more mobile friendly.

 www.Clerk.lacity.org/ncelection for more information. They have been working with the Durant Library to honor past election practices and using one of the conference rooms for elections. The candidate filing will be similar to prior years with candidates submitting applications using an online portal or paper application. Instructional videos and materials will be available. The deadline time to apply has been extended to 11:59 on deadline days. Staff will only be available to assist during normal business hours. Ballots will be mild 35 days prior to the election and must me returned and post marked by election day. Election staff will also be working as poll workers to administer voting on election day. The current city policy

regarding Covid will be followed which is proof of vaccination or negative test within the last 72 hours to enter a polling place. Anyone not able to provide the required documents will be asked to use the curbside voting. Masks are not required but strongly encouraged. The office will begin tallying votes the next business day after voting. This process can be observed in person or online. The results will be released thirteen days after the election. Voter turnout information will be made available by neighborhood council, region and citywide on the NC Election website. Information is available on the website for anyone interested in volunteering as a poll worked or independent grievous panel. HHWNC is part of region 5 and used to be the first neighborhood council vote. This election HHWNC will not be the first vote and the election is scheduled for April 30. Lanee can be reached at 213-978-0444 for any questions.

Jane Crockett, 2nd VP & Election Chair shared that all information regarding the election will be on the HHWNC website. Everyone on the board will be getting election information via e-mail. DONE will eb sending out a newsletter as well as an election newsletter specific to our region. Key dates to remember: In person election will be Sunday, April 20th. Candidate filing opens December 31 and closes February 14. Vote by mail is March 1st through April 11. Vote by mail deadline is April 18th. Jane and Kyle have been meeting with DONE monthly. DONE is tasked with outreach and works with the NC's and City Clerk. Lanee works on the voting. HHWNC will rely on the Area Chairs and their contacts and distribution lists. They will be working with the council offices for outreach as well. Angie Aramio will be working with community-based organizations for outreach. Kyle Naumovski, Outreach Chair is working on the social media. And shared that information is posted on Facebook, Instagram, Twitter and Next Door. He's looking forward to keeping the community informed.

b) The HOLLYWOOD PARTNERSHIP (formerly Hollywood BID): Presentation by Kathleen Rawson, CEO/President. Update on new goals; ambassadors, etc., for public safety, sanitation, etc., of Hollywood Boulevard. kathleen@hollywoodpartnership.com. Kathleen Rawson shared that she's new to Hollywood and spent 25 years in Santa Monica as CEO of Downtown Santa Monica. Hollywood Partnership is a geographically based organization. Business owners within the area vote to tax themselves funds to provide clean, safe hospitality, economic vitality economic development above what's provided by the city. Hollywood Partnership is a 501c3 and they have a budget of just over 8 million dollars. Another 501c# organization has been established and an additional 2 million dollars has been raised to support the organization. The main four pillars of the organization are: 1. Clean and Safe and if you've been on Hollywood Blvd there are folks out cleaning, removing graffiti and stickers. 2. Beautification projects. 3. Marketing promotions. 4. Advocacy and economic development. Someone from the organization will regularly attend neighborhood council meetings so they can stay connected with the residents. If residents are happy then businesses will thrive. Businesses within the boundaries can sign up to get information about meetings and have an equal voice as residents. You can call or text regarding over flowing trach cans or someone experiencing a mental episode for an example and a team member will be dispatched to address the issue. They are working business private property owners to link exterior security cameras with their dispatch center. This will allow the dispatcher to isolate cameras and will share the access to the police. The program will launch January 1, 2023. There will be 85 ambassadors. c) WILDLIFE ORDINANCE UPDATE: Review of Revisions made by LA City Planning in response to

Stakeholder, NC's & Neighborhood groups. Presenter: Dan Bernstein, HHWNC First President & Area 2 Stakeholder. Invited: Patrick Whalen, City Planning Associate, LA City Planning.

Patrick.whalen@lacity.org. Dan Bernstein shared a map of the Wildlife Ordinance that's in the HHWNC boundaries and discussed. Dan shared a summary put out by the planning dept of significant changes since the last ordinance revision. He mentioned the wildlife resources, ridgeline and removal of setbacks.

HHWNC supports the Wildlife Ordinance subject to the following conditions:

- 1) TRASH ENCLOSURES (District-Wide Regulation (j) Requiring all trash and recycling receptacles be stored inside a building or within an enclosed structure is unnecessary. Wildlife Ordinance (WO) Reg (j) must be changed to re-enforce that these receptacles be stored on private property in a secure area off the street and be maintained in good condition. Over the many years these receptacles have been in use, no one has reported to us any problems with wildlife opening the lids. Further, LA Planning could create an education program to inform residents of their responsibility (1) to get their receptacles repaired or replaced at no cost and (2) to prevent the receptacles from blocking any portion of the public right of way. Also see 7 below.
- 2) WILDLIFE RESOURCES (District-Wide Regulation 2.) -The staff report states the resource maps will be changed yearly. The ordinance must require these changes be reviewed and approved by City PLUM and, if the changes are significant, by the City Council.
- 3) SITE PLAN REVIEW (District-Wide Regulation 2.(b)) The required qualifications of individuals performing biological assessments and site plan review and those procedures must be described in this ordinance be included before it is approved.
- 4) District Identification (SEC. 13.21 "WLD" WILDLIFE DISTRICT) City projects within the Wildlife District MUST NOT be automatically exempt from this ordinance. A review should be required. At a minimum the written approval by that City Council District member where the project is located must be required to receive an exemption.
- 5) Administrative Clearance Director Authority for Sign Off (SEC. 4 of Subsection S of LA Municipal Code 12.32) The CPC, City PLUM and/or City Council must not approve the WO clearance until the Administrative Application form has been available to the public for 30 days prior to the hearing and/or vote.
- 6) Application, Form and Contents (Sec. 4. (b)) The application form(s) for an Administrative Clearance must be published and reviewed in a transparent public manner before this Wildlife Ordinance receive final approval.
- 7) Enforcement of the ordinance An enforcement group must be established and funded so that city employees travel through the Wildlife District and be responsible for education of the residence of the wildlife district and enforcement the requirements of this ordinance.

- a) CD4 Jorge Plascencia (Jorge.plascencia@lacity.org) & Mehmet Berker (Mehmet.berker@lacity.org), Office of Councilmember Nithya Raman. Mehmet shared the council office is still engaged at the Cahuenga 101 Bella Vista and now Franklin area. There have been some people moving into the neighborhood from further east and the homeless team is on it. Mehmet has been promoted to Sr. Deputy for Transportation, Infrastructure and Public space. He will be the point person on those issues. Josef Siroky will be moving over to cover Hollywood and HHWNC. The Ficus trees that have been planted on Mulholland and Macapa. LADWP has issued a notice of violation to the responsible party. The trees have been removed. Neighbors have expressed the desire for beautification which they support. The Geotech wall on pacific View Dr has been complete. He's talking with BSS regarding resurfacing. November 20th is World Day of Remembrance for road traffic victims. The office has City Hall lit in yellow for four nights. There have been 245 people killed this year and 198 people seriously injured. The numbers continue to rise. There are a couple of grants available LA Conservancy Legacy Business grant for businesses operating for 20 years. Information can be found on the LA Conservancy website. There is also a paid family leave grant for small businesses. 1-100 employees. CaliforniaPFL.com for more information.

Shon Wells (31394@lapd.lacity.org). Brian White shared there was a hearing for a Hookah/ Bar / Night Club on Hollywood Blvd that would easily influence HHWNC area. LAPD was able to testify and help the zoning administrator decide to block. He thanked the PLUM representatives for their time and helping protect the neighborhood.
- c) 25th Senate State District, Declan Floyd (declan.floyd@sen.ca.gov, District Representative, Office of Anthony Portantino. Declan thanked HHWNC for allowing Senator Portantino to speak at last months meeting, for questions and comments. There are some good ideas that have been passed to the Capitol office. He will get back to us on the legislative package in January.
- d) Department of Neighborhood Empowerment, Dina Andrews (dina.andrews@lacity.org). Dina shared EVGH work group limited hybrid pilot program and informal session has made lots of progress. Several neighborhood councils have been selected by EVGH. The group approved 14 initial participants and 7 back up choices. The Awareness and Engagement division is working with DOT to have neighborhood council awareness videos on Dash bus monitors. LADWP, Department of Cannabis Regulation, Office of Community Beautification and the Mayor's office of Public Engagement will be sharing general neighborhood council information in their newsletters. Three council files that are important to neighborhood councils, council file 210407 regarding standardized election role, stakeholder participation, council file 221070 regarding neighborhood council meetings and power, LA Virtual Governance System in person emergency declaration was introduced on September 14 by the City Council and refers to the arts, parks health and neighborhood committee Council file 221146 regarding community impact

statements, portal neighborhood council, transmission, city commissions, technological updates was introduced on September 13 and regard to the information technology and general services committee. The Board of Neighborhood Commissioners News, President Rogato has scheduled a tentative zoom BONC retreat January 22, 2023, at 1 pm. There were 3 bills signed by Governor Newsom, SB1100 open meetings, orderly conduct would authorize the members of the legislative body to remove an individual for willfully interrupting the meeting. The bill will go into effect January 2023. Bill 24409 open meetings, local agency and teleconferencing and AB 587 Social meeting companies and terms of services. Implicit Bias training is coming for gender expression and identity in partnership with the Civil and Human Rights and Equity dept and is based around council file 200990 and the Mayors executive directive 27 on racial equity and the city government. b) PARKS AND OPEN SPACE COMMITTEE REPORT: (Jeffery Masino)

President Anastasia Mann made a motion 2nd by Transportation Chair Kyrstin Munson. The motion was approved 21-0.

i. Motion: In order to ensure that Runyon Cyn Park remains an urban wilderness area park, the HHWNC remains opposed to the recent decision from Council District 4 and Los Angeles Rec & Parks to allow commercial vending in lower Runyon Canyon Park in any form or location. Our position is supported through numerous public meetings discussing the matter and input from stakeholders, which resulted in our previous letter dated March 16, 2022 (attached).

We strongly feel that the recent decision is not in the spirit of Recreation and Parks own Rules and Regulations for vending food and commercial items in LA City Parks (attached), which is based off of LA City Ordinance 185900 (attached), specifically that "no vending" restrictions are necessary to prevent an undue concentration of *commercial* activity that unreasonably interferes with the scenic and natural character of the Park, and further that restrictions are necessary to ensure the public's use and enjoyment of natural resources and recreational opportunities which would be impacted without them.

We therefore ask Council District 4 and Los Angeles Rec & Parks leadership to reverse this unfortunate decision and work with LA Rec & Parks to install clearly placed "No Vending" signage at all three main Runyon Cyn Park entrances (Fuller Ave., Vista St., and Mulholland Dr.).

 UPDATE: Joint meeting between LA Rec & Parks, HHWNC Board Representatives, and Friends of Runyon Canyon Foundation per 2016 agreement to hold transparent meetings on issues that affect Runyon Cyn Park. Agenda attached. (Mary Yarber, Jeff Masino, LA Rec & Parks rep, CD4)

Jeffery Masino shared that a December 2006 Rec & Park decision that HHWNC would work with Friends of Runyon Canyon on any meetings the had internally would be done jointly. Mary Yarber has been attending ever meeting. Mary shared that she participated in a zoom meeting and the four groups that are always represented are Rec & Parks, Stephanie Smith, Jorge de Laura, CD4 Mehmet Berker, Friends of Runyon Don Andres, Stacy Sillins, HHWNC Jeffrey Masino and Mary Yarber. Portable Restrooms will be installed on a trial bases on the lower part of Runyon Canyon. They will be installed far enough away so neighbors don't hear the doors opening and shutting all day. All gates work and lock properly. They are time locks and should be locked at dusk. There is always a problem with people propping gates open

with a rock. The East trail needs some work. Rec & Parks is still assessing how to perform repairs to the trail. The West trail stairs have been removed and they are trying to figure out the remedy. There will be some strengthening of the foot bridge. You can view the vending policy on the website. Rec & Parks has identified areas in the park where vending is legal. It's not allowed in the wilderness area of the park. HHNWC and Friends of Runyon are opposed to commercial vending in the park. Runyon bench donations have been put on hold for two years. Next meeting will be in Q1 2023.

Brian Dyer shared there was a meeting held to discuss what Stratiscope is doing. In holding meetings, by the end of the bowl season, they increased from 14-26 traffic control officers. They are still working on reversible lanes and will be coming back with data after Gibson Transportation does their study. Stakeholders were never asked about closures at Camrose and Milner. Ultimately it will be CD4 decision if the closures continue. Chris is working with Senator All and Portantino to change the law that was instigated by Whitley Heights when they tried to close off their streets and will be ringing this info back to the board. Brian, Oren and Ethan have been working with the Dream Hotel and other businesses because rooftops have been creatin so much noise in the hills. Ethan Weaver is looking at ways to try and prosecute them. An area 3 YouTube channel has been created to post videos of issues. The Dorothy and Benjamin Smith Park on Franklin renovation. Hollywood Blvd will be closed for 2 weeks for 2 movie premiers and the Christmas Parade.

An ordinance amending Section 42.13 of the Los Angeles Municipal Code to authorize creation of a Vending Program consistent with state law, amending Sections 42.00(b), 42.00(b)(5), 42.15.I, 63.44.B.3 and 66.44.R, deleting Sections 41.43 and 42.00(m), adding Sections 42.15.D.8 and 66.34.B.3(i) and deleting Article 11 of Chapter 13 of the Los Angeles Administrative Code.

- **WHEREAS,** a well-regulated vending program would enliven the City's streetscape by creating a vibrant marketplace;
- **WHEREAS**, because vending has a relatively low barrier to entry, vending encourages entrepreneurship;
- **WHEREAS**, providing economic opportunity for people to support themselves and their families is one of the most important goals for the City;
- **WHEREAS**, there is a need to regulate the sale of food and merchandise in the public right-of-way and in parks to protect the public's health, safety and welfare;
- **WHEREAS**, vending within 500 feet of popular tourist attractions and concert and sport venues on event days impacts pedestrian, tourist and vendor safety due to overcrowding on sidewalks, which results in pedestrians walking in the street and along the sidewalk to keep moving forward. These venues also experience a high amount of traffic, affecting the safety of pedestrians and motorists, due to a high concentration of visitors at one time:
- WHEREAS, El Pueblo de Los Angeles Historical Monument is listed on the National Register of Historic Places because of its status as the birthplace of the City of Los Angeles, and El Pueblo is visited by two million tourists annually who are already served by more than 70 vendors, many of whom are the descendants of the original El Pueblo merchants;
- **WHEREAS**, pursuant to Los Angeles Municipal Code Section 42.15.B, the space limitations, high volume of tourists and historic presence of First Amendment protected vending on the Venice Beach Boardwalk requires a ban on commercial vending to protect the health, safety and welfare of the public;
- **WHEREAS**, requiring licenses and permits to vend on sidewalks and parks benefits the health and safety of the public because it increases vendor accountability in following the City's rules and regulations by identifying vendors out of compliance with the City's vending program and protects vendors assigned to vend in certain locations;
- **WHEREAS**, regulation of vending benefits the City as a whole as it leads to orderly commerce; and

WHEREAS, the City Council seeks to create a vending program which will provide regulation of sidewalk and park vendors in Los Angeles.

NOW, THEREFORE,

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

- Section 1. Section 41.43 of the Los Angeles Municipal Code is deleted.
- Sec 2. Section 42.00(b) of the Los Angeles Municipal Code is amended to replace the title and amend the first sentence to read as follows:
- (b) **First Amendment Protected Vending.** Sections 42.13.A through 42.13.C and E of this Code do not apply to First Amendment protected vending as set forth below:
- Sec. 3. Section 42.00(b)(5) of the Los Angeles Municipal Code is amended to read as follows:
 - (5) **Penalty.** Any violation of this Subsection (b) shall be punishable pursuant to Section 42.13.D. of this Code.
 - Sec. 4. Section 42.00(m) of the Los Angeles Municipal Code is deleted.
- Sec. 5. Section 42.13 of the Los Angeles Municipal Code is amended in its entirety to read as follows:

SEC. 42.13. SIDEWALK VENDING PROGRAM.

- A. **Definitions.** For purposes of this section, the following words or phrases shall have the following meanings:
 - 1. **Citation**. An Administrative Citation issued pursuant to Article 1.2 of Chapter 1 of this Code.
 - 2. **City.** The City of Los Angeles, a municipal corporation.
 - 3. **Food.** Any type of edible substance or beverage.
 - 4. **Goods or Merchandise (Merchandise).** Any item that is not Food.
 - 5. **Park.** A "park" shall include every public park or other recreational facility in the City of Los Angeles which is owned, controlled, operated or managed by the Board of Recreation and Parks Commissioners.

- 6. **Person or Persons.** One or more natural persons, individuals, groups, businesses, business trusts, companies, corporations, joint ventures, joint stock companies, partnership, entities, associations, clubs or organizations composed of two or more individuals (or the manager, lessee, agent, servant, officer or employee of any of them), whether engaged in business, nonprofit or any other activity.
- 7. **Rules and Regulations.** Detailed requirements concerning the Vending Program meant to clarify and aid in the administration and enforcement of this section.
- 8. **Sidewalk.** Any surface in the public right-of-way intended for use by pedestrians.
- 9. **Vending Program.** The Vending Program regulates Vendors on Sidewalks and in Parks for the sale of Food or Merchandise.
- 10. **Vend, Vends or Vending.** To sell, offer for sale, expose or display for sale, solicit offers to purchase, or to barter Food or Merchandise, or to require someone to negotiate, establish or pay a fee before providing Food or Merchandise, even if characterized as a donation.
 - 11. Vendor. A Person who Vends.

B. Administration.

- 1. Rules and Regulations to implement the Vending Program on Sidewalks shall be developed and recommended by the Department of Public Works, Bureau of Street Services. The Rules and Regulations for Sidewalks shall be approved by the Board of Public Works and adopted by the City Council through resolution. The Rules and Regulations to implement the Vending Program in Parks shall be developed and approved by the Board of Recreation and Parks Commissioners and adopted by the City Council through resolution. The Bureau of Street Services and the Department of Recreation and Parks shall post the Rules and Regulations on their websites.
- 2. The Bureau of Street Services or its designee is authorized to issue Licenses and Permits for Vending Food or Merchandise and the use of carts on Sidewalks. In consultation with the Board of Recreation and Parks Commissioners, the Bureau of Street Services or its designee is authorized to issue Licenses and Permits for Vending Food or Merchandise and the use of carts in Parks.
- 3. On or after January 1, 2020, Vending without a license or cart permit shall be unlawful. Before the City makes available licenses and cart

permits to Vendors on or after January 1, 2020, Vendors must Vend in accordance with this section and the Rules and Regulations.

4. The City Council shall select a vending service provider through a competitive process, consistent with City law. The Bureau of Street Services shall monitor and assist the vending service provider with its duties and responsibilities.

C. Restricted Vending Locations.

- The City may establish through the adoption of Rules and Regulations certain limited areas where Vending may be restricted or prohibited. The Bureau of Street Services shall determine restrictions or prohibitions on Sidewalk Vending based directly on objective health, safety and welfare concerns. The Department of Recreation and Parks shall determine restrictions or prohibitions on Park Vending based on whether it is: 1) directly related to objective health, safety or welfare concerns; 2) necessary to ensure the public's use and enjoyment of natural resources and recreational opportunities; 3) necessary to prevent an undue concentration of commercial activity that unreasonably interferes with the scenic and natural character of the Park; or 4) necessary to comply with a condition in a deed conveying the property to the City. These restrictions or prohibitions shall be detailed in the Rules and Regulations and adopted by the City Council through resolution. For purposes of this section, perceived community animus or economic competition does not constitute an objective health, safety or welfare concern, pursuant to applicable state law.
- 2. Restricted Vending locations, as well as all conditions applicable in each restricted Vending location, shall be detailed in the Rules and Regulations and include, but are not limited to, the following:
 - (a) Vending is prohibited within the immediate vicinity of an area designated for a temporary special permit issued by the City, provided that any notice, business interruption mitigation, or other rights provided to affected businesses or property owners under the City's temporary special permit are also provided to a Vendor permitted to operate in the area, if applicable. For purposes of this paragraph, a temporary special permit is a permit issued by the City for the temporary use of, or encroachment on, the sidewalk or other public area, including, but not limited to, an encroachment permit, special event permit, or temporary event permit, for purposes including, but not limited to, filming, parades, or outdoor concerts. A prohibition on Vending pursuant to this paragraph shall only be effective for the limited duration of the temporary special permit.

- (b) Vending is prohibited within 500 feet of: 1) the Hollywood Walk of Fame, Universal Studios and the El Pueblo de Los Angeles Historical Monument (as described in Chapter 25 of Division 22 of the Los Angeles Municipal Code); 2) Dodger Stadium, the Hollywood Bowl, the Staples Center and the LA Coliseum on event days; and 3) any other venue as determined by the Board of Public Works or Board of Recreation and Parks Commissioners and published in the Rules and Regulations.
- (c) Vending at Venice Beach is limited to First Amendment protected expressive activities as set forth in Section 42.15.A.
- 3. The procedure for measuring the 500 foot vending restriction shall be specified in the Rules and Regulations. The Department of Public Works, Bureau of Engineering shall develop interactive maps available to the public disclosing locations with any restriction on Vending.

D. Enforcement.

- 1. A Vendor who is issued a Citation shall be subject to the following fines:
 - (a) Vending which violates a requirement in this section or in the Rules and Regulations, other than failure to possess a valid license or permit:
 - (1) An administrative fine of \$100 for a first violation.
 - (2) An administrative fine of \$150 for a second violation.
 - (3) An administrative fine of \$200 for a third violation and each subsequent violation.
 - (4) A violation occurring after 12 consecutive months with no violation shall be considered a first violation.
 - (5) A Vendor's license and/or permit may be revoked or suspended for the remainder of its term upon a fourth or subsequent violation.
 - (b) Vending without a valid license or permit:
 - (1) An administrative fine of \$250 for a first violation.

- (2) An administrative fine of \$500 for a second violation.
- (3) An administrative fine of \$1000 for a third violation and each subsequent violation.
- (4) A violation occurring after 12 consecutive months with no violation shall be considered a first violation.
- (5) The administrative fines listed in this paragraph may be reduced from \$250 to \$100, \$500 to \$150 and \$1000 to \$200 upon submission of proof of license and/or permit to the City Attorney's ACE citation processing center, as specified in the Rules and Regulations.
- 2. Additional fines, fees, assessments, or any other financial conditions beyond those authorized in Subsection D.1 shall not be assessed.
- 3. Unless otherwise specified herein, all Citations issued for violations of this section and the Rules and Regulations shall be enforced by the provisions set forth in Article 1.2 of Chapter 1 of this Code.
- 4. When issuing a Citation, the adjudicator shall take into consideration the Vendor's ability to pay the fine using the criteria described in Subdivision (a) or (b) of California Government Code Section 68632. Notice shall be given to the Vendor of his or her right to request an ability-to-pay determination and instructions or other materials for requesting an ability-to-pay determination shall be available. The Vendor may request an ability-to-pay determination at the adjudication stage or while the citation remains unpaid, including when a citation is delinquent or has been referred to a comprehensive collection program. If the Vendor meets the criteria set forth herein, the City shall accept, in full satisfaction, 20 percent of the administrative fine, imposed pursuant to Subsection D.1.
- E. **Services.** Unpermitted vending of services or anything other than Food or Merchandise in the City is unlawful and subject to the provisions of Section 11.00 of the Los Angeles Municipal Code. Vending of services is unlawful even if the vending of services is combined with the Vending of Food or Merchandise, and even if the services are deemed to be free of charge with the purchase of Food or Merchandise.
- F. **Extortion**. Any extortion of a Vendor will be punishable under Section 518 of the California Penal Code and any attempted extortion of a Vendor will be punishable under Section 524 of the California Penal Code.
- G. **Severability.** If any provision of this ordinance is found to be unconstitutional or otherwise invalid by any court of competent jurisdiction, that invalidity shall not affect the remaining provisions of this ordinance that can be implemented

without the invalid provisions and, to this end, the provisions of this ordinance are declared to be severable. The City Council hereby declares that it would have adopted this ordinance and each provision hereof irrespective of whether any one or more of the provisions are judicially determined to be invalid, unconstitutional or otherwise unenforceable.

- Sec. 6. A new Section D.8 is added to Section 42.15 of the Los Angeles Municipal Code to read as follows:
 - 8. Section 42.13 is not applicable to the First Amendment protected vending listed in this section.
- Sec. 7. Section 42.15.I of the Los Angeles Municipal Code is amended to read as follows:
- I. **Violations**. Any violation of this section shall be punishable pursuant to Section 42.13.D. of this Code.
- Sec. 8. Section 63.44.B.3 of the Los Angeles Municipal Code is amended to read as follows:
- 3. **Vending.** Vending in a public Park is governed by Section 42.13, except First Amendment protected vending as specifically allowed below:
- Sec. 9. Section 63.44.B.3(i) is added to the Los Angeles Municipal Code to read as follows:
 - (i) **Violations.** Violations of Subsection B.3 are governed by Section 42.13.D of this Code.
- Sec. 10. Section 63.44.R of the Los Angeles Municipal Code is amended to read as follows:
- R. **Violations.** Except for Subsection 63.44.B.3, a violation of this subsection is subject to the provisions of Section 11.00 of the Los Angeles Municipal Code.
- Sec. 11. Article 11 of Chapter 13 of the Los Angeles Administrative Code is deleted.
- Sec. 12. **URGENCY CLAUSE.** The City Council finds and declares that this ordinance is required for the immediate protection of public peace, health and safety for the following reason: The California legislature adopted a new law, effective on January 1, 2019, regulating vending statewide. The state law provides that local authorities may adopt additional vending regulations restricting or prohibiting vending under certain circumstances. The City Council finds that additional vending regulations are needed to

The Hollywood Hills West Neighborhood Council is one of the certified Neighborhood Councils in the City of Los Angeles. At a regularly scheduled board meeting on Wednesday, March 16, 2022, the topic of shielding commercial operations inside Runyon Cyn Park within the parameters of SB 946 was considered and the following motion passed 18 yay -o nay.

Motion: In order to ensure that Runyon Cyn Park remains an urban wilderness area park, the HHWNC requests that the Los Angeles Rec & Parks advocate, via a motion to the LA Parks Commission, a restriction / prohibition on Park Vending within Runyon Cyn Park, based on the provisions of LA City Ordinance 185900, specifically that 1) vending restrictions are directly related to objective health, safety or welfare concerns for parkgoers (vending activities often literally block emergency egress, ingress); 2) they are necessary to ensure the public's use and enjoyment of natural resources and recreational opportunities which would be impacted without them; 3) that these restrictions are necessary to prevent an undue concentration of commercial activity that unreasonably interferes with the scenic and natural character of the Park, and 4) that vending restrictions follow the 1986 Runyon Canyon Master Plan and Design Guidelines requiring the park be foremost a place for a wilderness experience. This motion is made with the support of the Los Angeles City Department of Recreation and Parks.

Recreation and Parks - Rules & Regulations for vending food and commercial items in LA City Parks

WHEREAS, the Department of Recreation and Parks (RAP) manages over 450 parks, 170 recreational facilities, golf courses, trails, beaches, museums, sites and facilities; and

WHEREAS, these collective sites include every public park, roadside rest area, playground, zoological garden, ocean, beach, museum, house, community garden or other recreational facility area, together with any parking lot, reservoir, pier, swimming pool, golf course, court, field, bridle path, trail, or other recreational facility, or structure thereon, in the City of Los Angeles which is owned, controlled, operated or managed by the Department of Recreation and Parks; and

WHEREAS, the City of Los Angeles has approximately 4 million residents and nearly 50 million annual visitors; and

WHEREAS, RAP desires to maintain its parks, open spaces and facilities as safe, well-programmed and accessible sites; and

WHEREAS, RAP desires to protect public safety and secure access while protecting the right of all people to visit and enjoy our public parks; and

WHEREAS, the California Legislature has adopted a statewide law (SB 946) allowing for commercial street vending of food and commercial items on sidewalks, including parks; and

WHEREAS, local park agencies may adopt vending rules and regulations in compliance with SB 946, including progressive administrative, non-criminal penalties; and

WHEREAS, a local park agency may restrict vendors to certain areas within a park where there is an objective health, safety or welfare concern; and

WHEREAS, a local park agency may limit the number of vendors to operate in a park where there is an objective health, safety or welfare concern; and

WHEREAS, a local park agency may restrict hours of operation for vendors which are not unduly restrictive; and

WHEREAS, a local park agency may require vendors to comply with sanitary conditions; and

WHEREAS, a local park agency may require vendors to obtain and possess State, County and City of Los Angeles permits; and

WHEREAS, a local park agency may require vendors to comply with the American with Disabilities Act and other disability access standards; and

WHEREAS, a local park agency may prohibit stationary sidewalk vendors from vending in parks park where it has signed an agreement for concessions that exclusively permits the sale of food or merchandise to a concessionaire; and

WHEREAS, a local park agency may restrict or prohibit sidewalk vendors within the immediate vicinity of an area where it has issued a temporary special permit for purposes including, but not limited to, filming, parades, festivals, concerts, movie nights, special events, carnivals, running events or other Department approved, temporarily permitted activities.

WHEREAS, the Board of Recreation and Parks Commissioners finds and declares that the following rules & regulations are:

- (i) Directly related to objective health, safety, or welfare concerns;
- (ii) Necessary to ensure the public's use and enjoyment of natural resources and recreational opportunities; and/or
- (iii) Necessary to prevent an undue concentration of commercial activity that unreasonably interferes with the scenic and natural character of the park; and

WHEREAS SB 946 does not restrict RAP from adopting rules and regulations for the prohibition of unauthorized or non-permitted commercial services in parks.

NOW THEREFORE, THE DEPARTMENT OF RECREATION OF PARKS ESTABLISHES THE FOLLOWING RULES AND REGULATIONS RELATED TO OBJECTIVE HEALTH, SAFETY AND WELFARE CONCERNS FOR VENDING OF FOOD AND COMMERCIAL ITEMS IN ALL CITY PARKS:

Time, Place & Manner

- As used in these Rules and Regulations, "Vend," "Vending" and "Vendor" shall have the same meaning as defined in Los Angeles Municipal Code Section 42.13.A.
- Vending is restricted to non-motorized conveyances, stands, or pushcarts, which
 must be not more than 8 feet in length and not more than 3 feet in depth, including
 wheels, axles and other appurtenances.
- Vendors shall not leave their vending conveyances, stands, or pushcarts unattended or unlocked. All vending conveyances, stands, or pushcarts shall have safety locks on their wheels.
- 4. Vending shall only be allowed at parks during their normal operating hours.
- Vending shall cease 30 minutes before the park's closing time to allow for cleanup and to ensure timely clearance of the vendor and patrons from park property. Vendors shall remove all vending equipment each day before the park closes.

- Vending shall be restricted to paved pathways or designated paved walking areas only. Vendors shall ensure that such pathways are not blocked, allowing for pedestrian and wheelchair/ADA clearance.
- Vending is not allowed on grass, trails, or dirt paths within a park or in parking lots or streets owned and operated by RAP.
- Vendors are prohibited from using any parking stall or designated parking area for vending conveyances, stands, or pushcarts to sell food or merchandise.
- Vending is not allowed in RAP maintenance or storage yards.
- Stationary Vendors are prohibited from selling food or merchandise in parks or facilities that have exclusive, signed concession agreements. (See Attachment A)
- 11. Vending is prohibited within 100 feet of any building, recreation center, bathroom, structure or playground.
- 12. Vendors are prohibited from vending within 500 feet of any school site, camp, youth activity center or senior center located on park property.
- 13. Notwithstanding the above rule, due to limited egress and ingress at the following venues, the abundance of heavy visitor traffic and, with respect to the Greek Theatre and Griffith Observatory, exclusive food and merchandise concessionaires, vending is prohibited as follows:
 - a. Within 2500 feet of the Greek Theatre on concert and event nights (See Attachment B);
 - Within 2500 feet of the Griffith Observatory or the Griffith Observatory's upper parking lot (See Attachment B); and
 - c. Anywhere in Elysian Park from three hours before the start until three hours after the end of all events at Dodger Stadium, including baseball games, concerts and races.
- 14. No vending conveyance, stand, or pushcart shall touch, lean against, or be affixed to any lamp post, parking meter, mail box, traffic signal, picnic table, fire hydrant, tree, plant, planter box, rock formation, bench, bus shelter, or trashcan.
- 15. Vending is prohibited within 5 feet of park benches or other park furniture and from within 10 feet of any crosswalk or ADA access ramp.
- Vending is prohibited within 25 feet of any park fountain, statue, monument, or art installation

- 17. Vending is prohibited in any park deeded, granted or otherwise gifted to the City with a restriction prohibiting commercial activity in the specified park. (Currently the only park with such a restriction is: Leimert Park).
- 18. No vendor shall vend anything that is placed immediately on a paved pathway or designated paved walking area, or on a blanket, box, or board placed immediately upon such surface.
- Vendors are prohibited from displaying off-site advertising.
- Vendors are prohibited from playing or operating any device to produce music or amplified sound for advertising or commercial purposes.

Capacity

- 21. The number of vendors per park shall be limited to: 2 vendors per acre and no vendor may vend within 25 feet of another vendor. (See Attachment C) RAP retains the right, as authorized by the Los Angeles City Council, to adjust the number of vendors allowed per acre for any individual park based on specific or unique physical characteristics of that park, which impact the amount of usable park space (e.g. lakes, hillsides or historical use or data that reflect an abundance of events or propensity to overly commercialize or impact park use).
- 22. The right to vend in a park shall be determined on a first come, first served basis until capacity is reached.
- 23. Vendors must keep accurate and contemporaneous logs of entrance and park departure times and must make those logs available to City staff immediately upon request.

Prohibitions on Vending During Temporary Permitted Events & Exclusive Concession Areas

- 24. Vending is prohibited during any park permitted filming, festival, concert, movie night, special event, carnival, parade, running event or other Department approved, temporarily permitted activity.
- 25. Vendors are prohibited from vending 500 feet from any permitted farmer's market or swap meet.

Requirements for Sanitary, Safety and Clean Conditions

26. Vendors must ensure that their vending activities and conveyances are clean and sanitary and in compliance with all rules and regulations of the Los Angeles County Health Department.

- 27. Vendors are responsible for clean-up and removal of any food item, package, refuse, waste, litter or any items or materials occurring because of or related to their food and merchandise sales.
- 28. Vendors are prohibited from placing any liquid or solid waste in park trashcans. Vendors are prohibited from dumping ice on park property.
- 29. Vendors must bring their own vermin-proof trash receptacles and remove any and all waste, refuse and litter collected or discarded as a result of preparing, selling or consuming food items or merchandise in the park.
- 30. Vendors are prohibited from hooking up to or using any water or electrical or gas outlets for the sale of their food or merchandise.
- 31. Vendors shall not sell or offer any unsanitary, unsafe, dangerous or harmful food, beverage or merchandise.
- 32. In addition to prohibitions on the sale of alcohol, ammunition, animals, counterfeit goods, firearms, or tobacco, which exist in local, state or federal law, by these Rules and Regulations, vendors are prohibited from selling or offering any harmful or dangerous items, such as archery equipment, knives, or sling shots, or any objects that appear to be weapons, such as squirt guns, toy guns, or toy knives.


Requirements to Possess, Maintain & Display Permits

- 33. Vendors must maintain, possess and display or show all local authority permits required by the State, County or City of Los Angeles.
- 34. Nothing in these rules shall restrict or prohibit the expression of any traditional speech or vending of expressive items such as newspapers, leaflets, pamphlets, bumper stickers, patches and/or buttons.
- 35. Nothing in these rules authorizes vending of personal services, whether free or for sale, including but not limited to boot camps, massage services, yoga, dog training, animal rides, petting zoos or sports/fitness classes.

Fines & Violations

36. Violations of these rules and regulations shall be punishable as non-criminal fines under the City's Administrative Citation Enforcement (ACE) pursuant to Los Angeles Municipal Code Section 42.13D.
