- III. **Approval of the Minutes of the Regular Meeting 11/15/2023.** President Anastasia Mann made the motion to approve the minutes as submitted, 2<sup>nd</sup> by Infrastructure Chair, Graham Rossmore. Meeting minutes approved 17-0
- IV. **President’s Report, by President, Anastasia Mann**
  - a. **HAPPY NEW YEAR – welcome back** – majority of board voted for ZOOM – We need to discuss options as all meetings cannot be via Zoom – concerns of some are the loss of face to face with stakeholders and public officials. Short discussion re next meeting (I cannot run February as I am having another surgery on Jan 25 and will be out for at least a month.

  - b. **ENVIRONMENT CHAIR, Jeffery Masino**, resignation due to injuries from a recent accident while traveling abroad. ENVIRONMENT Chair is now open for candidates to apply to [president@HHWNC.org](mailto:president@HHWNC.org) with proof of stakeholder status. Position has been posted on the website. Possible election at the February 21<sup>st</sup> meeting (30 days posting required). Former Board Member Cheryl Holland is considering running for the office since she’s previously held the position. Hopefully we can have a vote in February.
  - c. **WEBSITE REVIEW – Chris Wintrode** has requested the board consider a new website for HHWNC. David – while capable – does not have time to take this project on but will prepare an RFP for possible applicants. Applicants must be approved vendors of the City of LA. We will update on current vendor list and determine next steps and appoint a review committee. HHWNC Administrator has offered to prepare a write-up of basic website needs.

President Anastasia Mann shared that there was also discussion with Hollywood United and Central Hollywood Neighborhood Councils and there were no possibilities to host a debate.
  - f. **UPDATE:** Status of NPG filed for Junior Achievement. President Anastasia Mann shared that the NPG has been approved for \$5,000 for students to participate in the simulation which was unanimously approved.
  - g. **CD4 Report – Mehmet Berker & Josef Siroky:** Speed hump update (Mulholland etc) and Tour Bus Street restrictions -signage and enforcement.

Josef Siroky shared that the 3 remaining speed humps will be installed February 15

through February 16. The installations are a full day job and will require full lane closures. The signs for the tour buss ordinance should go up after March 8. They have been working with the General Services division to get 489 signs fabricated and installed for \$75,000.

He's requested the clearing of most storm drains on outpost. If there are any arteries that he's missed let him know. Bureau of Street lighting is backlogged right now.

Anais Gonzalez shared that she had reached out to the Dept of Cannabis regulation to see if there were any updates regarding the Backpack Boyz dispensary that had opened. She had not received a response to her e-mail. The most pressing issue right now has been working with Brian Dyer and the other neighborhood councils on the neighborhood meeting with the Oscars which are March. She will coordinate meetings with the neighborhood to go over their street closures.
- c. LAPD –Hollywood, Captain Craig Heredia ([31900@lapd.online](mailto:31900@lapd.online)); Hwd Hills, SLO Ralph Sanchez ([30735@lapd.online](mailto:30735@lapd.online)); Hwd Ent, Officer Brian White ([38074@lapd.online](mailto:38074@lapd.online)); Hwd Flats, SLO Brian Oliver ([37349@lapd.online](mailto:37349@lapd.online)); NoHo, Officer Kurtis Delbar ([38887@lapd.online](mailto:38887@lapd.online)); Lt. Shon Wells ([31394@lapd.lacity.org](mailto:31394@lapd.lacity.org)). Kurtis Delbar shared that a home burglary crew has been using 2<sup>nd</sup> story master bedrooms to enter homes and exit through the front door or the original entry point. Typically, alarms are not armed. He suggested to make homes look occupied and pay attention to your surroundings because these crews are scouting for targets. Please use MYLA311 App for city resources. If you see homeless encampments use LAHop which provides resources like housing or medical services.
- d. 3rd Supervisorial District - Office of Supervisor Lindsey Horvath, Amanda Laflen, Constituent Services, ([ALaflen@boslacounty.gov](mailto:ALaflen@boslacounty.gov)) Supervisor Lindsey Horvath ([Lindsey@bos.lacounty.gov](mailto:Lindsey@bos.lacounty.gov)) Amanda shared that the Supervisor is the Chair of the Board. The LA Homeless count is coming up on the January 25<sup>th</sup> and they are looking for volunteers. The Board passed a motion urging the Federal Government to support a robust 988 system to respond to mental health crisis throughout La County with a response where the area code did not matter. Currently these calls are routed depending on your area code.
- e. 51st Assembly District, Joshua Marin ([JoshuaMarinM@ASM.CA.gov](mailto:JoshuaMarinM@ASM.CA.gov)) Office of Assemblymember Rick Chavez Zbur. Joshua shared that the Assemblymember sits on the budget, judiciary labor and employment rules, business, and professions committees. He is also the Chair of the new Retail Theft committee which has had it's first meeting and the second will be in LA.
- f. 24<sup>th</sup> State Senate District, Jake Ettinger, ([Jake.Ettinger@sen.gov](mailto:Jake.Ettinger@sen.gov)), District Representative, Office of Ben Allen. Jake shared that the state is looking at a \$38 to \$68 Billion dollar deficit this year. There will be some delayed funding. There is also a rainy day reserve and they will be able to draw from those funds. There are some things that may need to be cut this year. There are two bills left over from last year including a climate bond that will hopefully be on the fall ballot which would be a \$10 Billion dollar climate investment.

Jake Artan shared that the budget has been covered and the Senator is ensuring that any money secured in the previous budget doesn't get moved around. He's making sure that we can defend the budget for the cities that they're covering. If there are any legislative ideas, please share them. The Senator has possibly 9 Bills right now and they are bringing back some Bills that didn't see success last year.

Department of Neighborhood Empowerment, Dina Andrews ([dina.andrews@lacity.org](mailto:dina.andrews@lacity.org)) Dina shared that the most recent BONC meeting was canceled but they will be visiting the anti-bias, gender identity and expression code of conduct training and how to implement it. There will be 60-90 days before this has to be addressed. She's not sure if the anti-

bias training will have to be. ken again or put on a 2-year cycle. The expression and gender identity training is new. The team has created a new FAQ document with helpful terms and definitions. She will contact the NC regarding the zoom license in Feb. There will be a women's empowerment event is March dedicated to women in the neighborhood council system. The 2024 Youth conference was a success with 60 youth selected to participate. Please let the office know about events and she will let you know if there is any SWAG available to support. There have been some complaints regarding the City Clerk's office. Please send any e-mail or questions.

Specifically, people with experience with non-profits and non-profit finances. There will be a vaccine clinic January 30-31 at the library with the Dept of Health giving Covid and flu vaccines. Cybernot is available every other Tuesday to assist people with computer literacy.
