d. THE COMMUNITY LAW CORPS: Isabella Bolton Torres presentation on this new department of the City Attorney's Office replacing the position of the former Neighborhood Prosecutor's responsibilities within the community.

The office is in the process of being set up and it will primarily deal with civil issues within

our communities. They will receive public and NC input regarding quality-of-life issues including Party House abuses, etc. Party House issues are now considered potential criminal offences and they will be directed by this office to a city attorney dealing with criminal matters.

REPORT submission:

The Community Law Corps (CLC), is a new division within the City Attorney's Civil Branch that serves as the first point of contact for L.A. residents. For your area, there is Deputy City Attorney Mehrnoosh Naderi, and Community Resource Specialist (Coordinator) Isabella Bolton.

CLC is a small new unit with three attorneys and three coordinators, with years of experience in civil and criminal law. The CLC takes preventative and proactive measures to address a variety of issues that affect neighborhoods and establishes partnerships to resolve problems that enforcement, alone, cannot adequately address. Collaborating with community members, city departments, outside government agencies and law enforcement partners, the CLC identifies and resolves challenging legal issues faced by many city neighborhoods.

Recently, CLC has received emails from the community related to nuisance properties. Our team looks up information on the home ownership and works with law enforcement and LADBS, to bring the owner into compliance. Another issue that comes up is party houses. CLC, which is on the civil side, works with the Criminal Branch, Planning, and LAPD, to tackle these party house nuisance locations.

Please consider the CLC a new tool in your toolkit when there is a quality of life nuisance in your neighborhood.

Senator Portantino's SB 411 (Council File #23-1114) to allow Neighborhood Councils to have the option choose to resume conducting meetings virtually or "in person".

MOTION FOR Community Impact Statement (CIS):

In accordance with Senator Portantino's successful SB 411, the approval signature of California Governor Newsom, the unanimous vote of approval of the City Council's resolution – Council File #23-1114 – the HHWNC Board of Directors supports and approves allowing Neighborhood Council Boards and Committees to meet virtually. This option will encourage and increase additional overall public and board participation due to easier accessibility for those who may be restricted to home stay, prohibited by excessive traffic issues and/or require health and safety protections, etc., making it more difficult for in person participation.
