1st Vice President Stuart Ross made the motion, 2nd Treasurer, Dan Bernstein. Motion passed 18-0

- IV. President's Report, by 1st Vice President, Stuart Ross
 - a. Update: BY LAW REVIEW: EXEC COMM Members VP AND 2nd VP By-law review Report and recommendations. Deadline April 1.

Jane Crockett shared that she and 1st Vice President Stuart Ross were representatives of the executive committee and they have reviewed by laws for any changes. Every neighborhood council would have to submit changes by April 1. The following changes are proposed:

Motion: HHWNC BY-LAW CHANGES

1. STAKEHOLDER STATUS

REPLACE---Article IV: (1) & (2) [pg 10]

Neighborhood Council membership is open to all Stakeholders. "Stakeholders" shall be defined as everyone who lives, works or owns real property in the neighborhood and also to those who declare a stake in the neighborhood as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the neighborhood council's boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations.

AREA 7 BOUNDARY

CLARIFY Article III: Section 1B

Western Boundary: Hollywood Blvd at Crescent Heights South to Sunset at Crescent Heights Blvd to City of West Hollywood border (just west of Havenhurst - 8212 Sunset Bl)

2nd Vice President Jane Crockett made the motion, 2nd by Treasurer Dan Bernstein. The motion passed 20-0

Motion: The Hollywood Hills West Neighborhood Council (HHWNC) Board approves of adding to the April 2024 agenda the topic of the President creating a 'Rules and Bylaws' workgroup, made up of volunteers from the HHWNC Board and HHWNC Stakeholders who will be tasked with reviewing the HHWNC Standing Rules and HHWNC Bylaws and recommending updates to them for HHWNC Board review and approval.

Transportation Chair Chris Wintrode made the motion, 2nd by Area 5 Chair Charlie Coker. Motion passed 19-1

(Due to the multiple comments by Board members regarding the motion being in compliance with the Brown Act, Dina Andrews made a stipulation that action would be researched within 24 hours, and subject to DONE verifying that it was in compliance.)

Standing rules modification.

Motion: HHWNC hereby amends the Standing Rules of HHWNC as follows:

2. Add the following three sentences at the end of the first paragraph of the Required Meetings section; and

"For the sake of clarity, there are existing stakeholder lists of emails for each Committee. When sending emails to such lists, the Committee Chair may only send emails to the designated Committee stakeholder list created and designated for such Committee. If the Committee Chair wishes to send emails to another committee's stakeholder list, other than as provided in the following paragraph regarding joint meetings, the Committee Chair must obtain the prior written consent of the President."

3. Add the following two sentences at the end of the second paragraph of the Required Meetings section.

"The Committee Chair may send emails to the designated Committee stakeholders email lists created and designated for each of the Committees participating in the joint meeting, IF first authorized by the other Committee Chairs to send such emails regarding the joint meeting. Access to other stakeholder lists remain subject to the prior written consent of the President as noted in the preceding paragraph."

The amended Required Meetings section of the HHWNC Standing Rules would read as follows (italics added to denote revisions).

Required Meetings

The HHWNC Bylaws require that Area and Issue Committees meet a minimum of four times per calendar year. Each Committee Chair is responsible for preparing meeting

agendas and meeting minutes. The Committee Chair is also responsible for having meeting agendas and meeting minutes of all meetings posted on the HHWNC website and sending emails to the Committee stakeholder list to provide notice of any upcoming meetings to those stakeholders. For the sake of clarity, there are existing stakeholder lists of emails for each Committee. When sending emails to such lists, the Committee Chair may only send emails to the designated Committee stakeholder list created and designated for such Committee. If the Committee Chair wishes to send emails to another committee's stakeholder list, other than as provided in the following paragraph regarding joint meetings, the Committee Chair must obtain the prior written consent of the President.

In the case of meetings held jointly by more than one committee, each Committee Chair shall be credited for having held a meeting. The Committee Chairs shall decide amongst themselves who will prepare and post the meeting agenda and meeting minutes. The Committee Chair may send emails to the designated Committee stakeholders email lists created and designated for each of the Committees participating in the joint meeting, IF first authorized by the other Committee Chairs to send such emails regarding the joint meeting. Access to other stakeholder lists remain subject to the prior written consent of the President as noted in the preceding paragraph.

If a Committee Chair organizes a community event involving HHWNC stakeholders, the Committee Chair shall be credited with having held a "meeting" for the purposes of complying with the HHWNC Bylaw requirement to hold at least four meetings per calendar year.

Dina shared that policy across the Neighborhood Council system is that bylaws can only be changed every two years. This year is for bylaw updates and next year is for elections. When we do bylaw reviews, updates, amendments or board restructuring, those have to go before BONC, Board of Neighborhood Commissioners.

1st Vice President Stuart Ross made the motion, 2nd by Area 3 Chair Brian Dyer. Motion passed 20-0

a. Discussion regarding an 11-story apartment building proposal, fast tracked as an ED-1 project. Building is on Floyd Terrace, near Barham. Issue is combined with Area 1. ED-1 projects are exempt from community review. Stuart Ross shared that a PLUM meeting was held but it was too late to submit a motion because agenda submission had closed.

Naomi Kobrin shared that she's been to LA Planning with Jeff Gavi. They were not able to see the planner assigned to the project. They were able to speak to other planners and get come clarity on how they are looking at the 81 ED-1 projects. Projects must comply with the objective standards of the zone like setbacks height limits, floor area ratio etc.

Motion: Motion: HHWNC Board objects to the project approval for the proposed multifamily development at 3446-3450 Floyd Terrace, because the project does not adhere to the requirements of the Los Angeles Executive Directive No.1 guidelines, whereby plans should not require any zoning change, variance, or General Plan amendment. In addition, the project does not appear to comply with relevant Hillside Area Ordinances. Currently requested variances propose life-safety issues, on a site that is within a Fault Zone, on a Poorly Constrained slip type, in an identified Landslide area, and a Very High Fire Hazard Severity Zone. Affordable Housing on a site that poses life safety issues should also consider that housing should be provided while Affirmatively Furthering Fair Housing (AFFH).

Walker shared that Josef Siroky is no longer with the office and he will be covering the Hollywood area along with Emma Taylor. The council office will be hosting a webinar about the Cahuenga 101 underpass inside safe operation.
- b. CD13 Anais Gonzalez (Anais.Gonzalez@lacity.org) Office of Councilmember Hugo Soto-Martinez. Anais shared that speed bump applications will open tomorrow at 9 am. There will be a press conference for Access of Hollywood, which Councilmember O'Farrell called the Heart of Hollywood, at Metronine Plaza at 9 am.
- c. 51st Assembly District, Joshua Marin (<u>JoshuaMarinM@ASM.CA.gov</u>)Office of Assemblymember Rick Chavez Zbur. Joshua shared the assemblymember introduced the California retail theft reduction act. He's the chair of the select committee on retail theft. There have been hearings in Sacramento and West Hollywood and they are planning one in San Francisco. The new bill places great emphasis stopping organized rings. It specifies that the value of thefts from different victims can be aggregated to reach the threshold for grand theft. This bill will expand the tools for police to arrest based on witnesses, sworn statements or video footage.
- **d.** 25th Senate State District, Talin Mangioglu (<u>Talin.Mangioglu@sen.ca.gov</u>), District Representative, Office of Anthony Portantino. Declan shared Senator Portantino is

- termed out at the end of the year. The Senators bills are going through committee hearings. Take advantage of the time he has left in office.
- e. Department of Neighborhood Empowerment, Dina Andrews (dina.andrews@lacity.org) Dina shared that there are three trainings available. Anti Bias is one, and if you've taken it you don't have to retake it. There is a new Code of Conduct that's not on the cornerstone platform yet. Gender Identity and Expression is new training and has to be taken by everyone. It's currently on the cornerstone platform. All three training have to be completed by June 3, 2024. SB411 FAQ sheet states that NC's must have a quorum within the City of Los Angeles boundaries. March 15 was the last day to sign up for the women's leadership event which is happening March 28. The NC has two homeless liaison seats available if you would like to nominate additional members. The fiscal year ends in June, and if you have any large credit card purchases above your current limit, please put it on your agenda for next month to increase your credit card limit.
