#### **SB 411 Updates:**

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

IV. **President's Report, by Second Vice President, Jane Crockett**

- a. **Opening Remarks.** Second Vice President, Jane Crockett, announces the next Neighborhood Council Meeting will be October 15<sup>th</sup>, 2025. .
- b. **Motion on LA City Council's Resolution to Oppose SB79.** Some members of the Board expressed concern over SB79 citing loss of local control over development and mayoral opposition to the bill. It was mentioned that the bill may not apply to smaller cities such as Beverly Hills, however the SB79 does apply to the City of Beverly Hills.

**Motion B:** HHWNC is in support of LA City Council's resolution to oppose SB79 by Second Vice President, Jane Crockett.

SOL Joseph Raviol reported: Burglaries are down 14% year-to-date; property crimes down 17%. Stolen vehicles decreased 45%; increased patrol visibility in Hollywood Hills. Residents encouraged to secure valuables and install security cameras. SOL Brian Oliver added: Recent violent crimes in Hollywood were isolated incidents. LAPD offered to host local town hall meetings to address community concerns. Officer Kurtis Delbar added: Recent attempted burglary on September 4th foiled by alert homeowner. Reminded residents to report noise or nuisance issues (e.g., bars on Cahuenga).

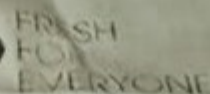

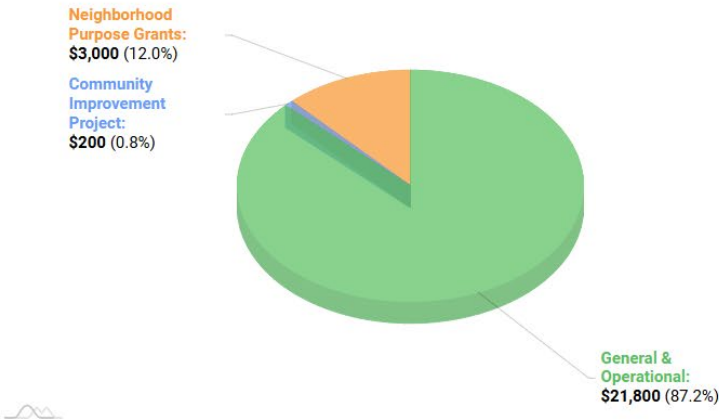

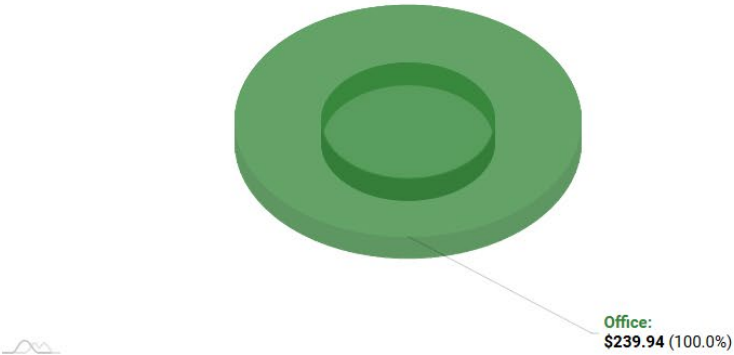

**Sacramento, CA – August 20, 2025** – The California Residential Mitigation Program ([CRMP](#)) announced today its second Earthquake Brace + Bolt ([EBB](#)) grant registration period for 2025, running from August 20 through October 1. For the first time, this open registration expands eligibility to include non-primary residential properties, giving landlords and other property owners the opportunity to apply for seismic retrofit grants to strengthen wood-framed, homes built before 1980 with raised foundations against earthquake damage.

Following the successful registration of nearly 19,000 homeowners during the January registration period, CRMP is initiating a second registration phase. With more than 1,100 eligible ZIP Codes across the state - including 303 added earlier this year - qualified homeowners can apply for grants of up to \$3,000 to help cover the cost of bolting houses to their foundations and bracing crawl space walls. These seismic retrofit upgrades help to reduce earthquake damage and provide more resilient housing in high-risk areas.

More than \$20 million in grant funding will be available to help offset the cost of seismic retrofits. Since the 2013 EBB program launch, more than 32,500 California homeowners have received grant assistance for strengthening their homes against earthquake damage. The EBB grant program is administered by CRMP, a Joint Powers Authority between the California Earthquake Authority ([CEA](#)) and the California Governor's Office of Emergency Services ([Cal OES](#)).

"Offering a second registration period this year is a valuable opportunity in helping us meet the strong demand we've seen for earthquake retrofit assistance," said Janiele Maffei, Chief Mitigation Officer, California Earthquake Authority. "By opening eligibility to include non-owner-occupied residential properties, we are helping ensure more of California's older homes, including rentals, can be strengthened against earthquake damage. Retrofitting is one of the most effective ways to reduce the risk of severe damage in a major quake, protecting both residents and the communities they call home."

Income-eligible homeowners may also qualify for supplemental grants. 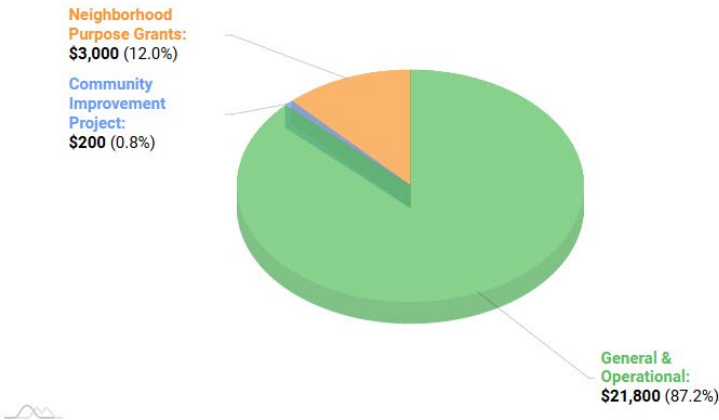

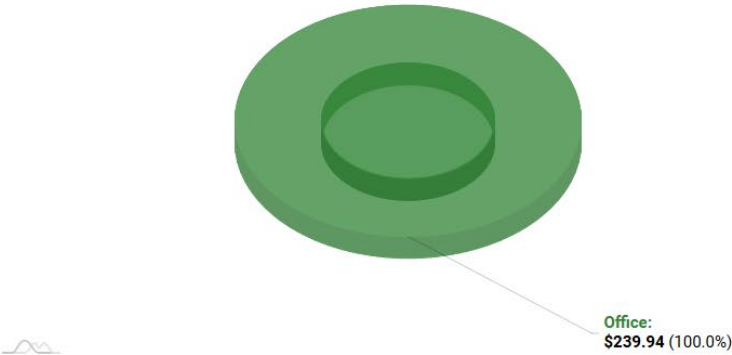
