#### **SB 411 Updates:**

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

## Background

- AB 3074 (2020) called for regs to create an “ember-resistant” zone within Zone Zero (5 feet from a home)
- AB 1455 (2025) provides Board of Forestry (BoF) with emergency power to implement Zone Zero regulations
- “Ember-resistant” has morphed to “combustion free”
- Under enormous public pressure, in October the BoF offered options for Zone Zero

# Options for Zone Zero



## Options for Landscaping Materials/Vegetation:

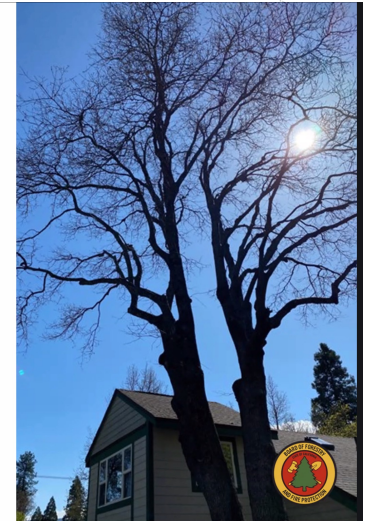
All options exclude fallen leaves, weeds, and combustible mulches

- Option 1 – Some plants in pots allowed
- Option 2 – Some plants in pots and low, maintained vegetation allowed
- Option 3 – Some plants, in pots or planted, allowed
- Option 4 – Well maintained plants allowed (The current requirement for vegetation in Zone 1)



## Options for Trees

- Option 1: Well-maintained trees allowed with no limbs in Zone 0, local tree ordinances included.
- Option 2: Well-maintained trees allowed, branches must be 10 feet from chimneys (This is the statutory minimum requirements).



Tree options now are less damaging, and the BoF has indicated that protected species will be spared



**Vegetation Option 4 / Tree Option 2 would provide a “local control” option**





## Communities Seeking Local Control

- Los Angeles City Council, Glendale, Ventura County Board of Supervisors – all unanimous votes
- 95% of comments received by the Zone Zero Committee favored Option 4 / Option 2



**Unfortunately: the Zone Zero Committee and CALFIRE have dismissed the possibility of local control**

## BoF / CALFIRE October Visit to Los Angeles



- CALFIRE officials were dismissive of Option 4 / Option 2, as was the Zone Zero Committee Chair: “It would be as if we did nothing - that’s the status quo.”
- CALFIRE officials were completely indifferent to the economic, ecological, and environmental costs of clear-cut Zone Zero regs; Zone Zero Committee Chair and staff member appeared more empathetic about compliance costs
- When members of the host team pointed out indications that vegetation had protected a structure, that was “anecdote” and, by implication, unreliable; when BoF / CALFIRE team members pointed out vegetation they claimed contributed to structure loss, that was “proof” (even where there were nearby examples of protective vegetation / trees)

## Most Recent Zone Zero Committee Meeting



- Speaker #1 presented an experiment that “proved” hydrated hedges will burn (this was not a surprising result – if exposed to direct flames, flammable stuff will burn; also, this was a radiant heat experiment, not a ember-resistant experiment)
- Speaker #2 was a firefighter who insisted that Zone Zero had to be “combustion free” (there is no legislation indicating that requirement)
- At the end of the meeting two of the three Zone Zero Committee members indicated their support for stringent one-size-fits-all Zone Zero regs

# What's Likely to Happen Next



- The most stringent Zone Zero regs are likely to be promulgated (either through the Zone Zero Committee, AB 1445 emergency order, or both) – **no local control**
- Homeowners will have three years until full compliance; homeowner-landlords renting out their homes may be compelled to comply immediately



## Potential Emergency Rulemaking Timeline

- Committee Directs Staff to prepare rulemaking documents at the December Meeting (12/10/25).
- Full Board approves emergency rulemaking package at January meeting (1/14/2026)
- Notice rules late January
- Submit to OAL late January/early February – begin emergency comment period
- Emergency rules in effect early February.
- If OAL review/comments reveal a need for updates, Board will consider amended emergency rulemaking package at March meeting. Emergency rules in effect in April.
- Continue standard rulemaking process in Committee/before the Board.



**High likelihood of a legal challenge to these regs;  
Zone Zero may be an important 2026 election issue**

## What Can You Do?



Zone Zero mandates sell false hope. There is no guarantee that homes with a cleared Zone Zero will survive an urban conflagration, or that these homeowners will be offered insurance.

**So what can you do?**

- 1) **Right now send your disapproval of clear-cut, one-size-fits-all Zone Zero regs to [PublicComments@bof.ca.gov](mailto:PublicComments@bof.ca.gov)**

We oppose one-size-fits-all Zone Zero regulations that will cost 10s of billions of dollars – and inflict disastrous ecological and environmental harm – without any cost-benefit analysis or provable fire safety benefit. We strongly support local control of Zone Zero regulations. Please include Vegetation Option 4 and Tree Option 2 in the final Zone Zero regulations.

- 2) **Contact your elected officials with the same message.**
- 3) **Get ready for “Round 2.” Oregon’s voter revolt got their state government to repeal clear-cut Zone Zero clearance regs . . . and apologize!**
- 4) **In early 2026 we’ll need a MASSIVE response to the “emergency comment period” triggered by AB 1455. We’ll forward instructions when available**
